**Anticipated Improvements:** The general description of the nature of the improvements included in the agreement is as follows:

IP Meitner, LLC anticipates constructing a wind energy facility with 460 MWAC of nameplate capacity. Improvements may include (but are not limited to) installing turbines, substation, transmission lines and collection cables, operation and maintenance building, interconnection facilities, meteorological and associated towers, access roads, foundations, paving and fencing.

**Estimated Cost of the Improvements:** The estimated cost of the improvements being contemplated by IP Meitner, LLC is approximately \$714,000,000.00.
