BUSINESS AND COMMERCE CODE TITLE 5. REGULATION OF BUSINESSES AND SERVICES SUBTITLE A. GENERAL PRACTICES CHAPTER 71.

Sec. 71.155. FILING FEES. (a) Except as provided by Subsection (a-1), the county clerk shall collect a fee of:

- (1) \$2 for filing each certificate or statement required or permitted to be filed under this chapter; and
- (2) 50 cents for each name to be indexed.

(a-1) The county clerk may waive all fees under Subsection (a) for a registrant who is a military veteran.

In this subsection, "military veteran" has the meaning assigned by Section 55.001, Occupations Code.
