MISCELLANEOUS FEES

County Certified Copy : \$1 per page copies + \$5 certification fee. (Stamped and sealed on each page. Sealed certification at the end.)

District Court Case Certified Copy: \$1 per page copies + \$1 certification fee. (Stamped on each page, raised DISTRICT seal on the computer-generated certification page at the end of the document).

Birth Certificate (Certified Copy Only): \$23.00 each= \$20.20 Birth Certificate + 1.80 State Birth Certificate + \$1 Vital Statistics Fee. Open for Public Inspection after 75 years. Before that the application is necessary from qualified applicants.

Death Certificate (Certified Copy Only): \$21.00 for first= \$20.00 Certified Copy Fee + 1.00 Vital Statistics Fee and \$4.00 for each additional = \$3.00 Certified Copy Fee + 1.00 Vital Statistics Fee. Open for Public Inspection after 55 years. Before that the application is necessary from qualified applicants.

Marriage License (Certified Copy only): \$5 certification fee + \$1 per page of license (can range from 1-2 pages).

Assumed Names: \$.50 per name + \$5 RM + \$2 Assumed Names+ \$1 for copy* = \$9 for 2 names (typical). (*the copy is optional).

Brand Registration: \$5RM + \$5 Brands= \$10 per brand per location.

Federal Tax Lien & Release: \$5RM + \$5 Fed. Tax Lien= \$10 no matter how many pages. Recorded in Deed/OPR records, released in Deed/OPR records. Be sure to index release volume and page and date on original lien record's indexing in computer and/or volume's index. Attach release to the original lien in the Federal Tax Lien folder.

State Tax Lien & Release: \$5RM + \$5 Rec.= \$10. As of 8/16/2012, they're recorded & released in the State Tax Lien Volume. Indexed in the front of that volume and in the computer indexing program. When recording release, note on the original lien's index the date and if it's a partial release in computer and/or volume's index.

Marriage License Application: \$65 if the couple has not completed the Texas Tomorrow Counseling course= \$30 marriage license +\$30 state marriage license + \$5 RM, \$5 RM fee is the cost with completion of Texas Tomorrow Counseling course. Index in Marriage License Index and the front of Marriage Record volume.

Abstract of Judgment: Recording: regular recording costs. See Property Code 52.003 requirements to ensure it's recordable. Issuance: \$8.
